






Fig. 3 - Typical Instantaneous Forward Characteristics




Fig. 5 - Typical Reverse Leakage Characteristics




Fig. 2 - Maximum Non-Repetitive Peak Forward Surge

8.3 ms Single Half Sine-Wave





Fig. 6 - Typical Reverse Leakage Characteristics
