At present, the RTE Series is using Black Opaque Tape & Reel Packaging as shown below:



We have identified a new Transparent Opaque Tape & Reel Packaging which we will be introduced as shown below:



The advantage of the utilizing the Transparent Opaque Packaging is:

- Allow a better eye-visual inspection of the RTE switch during incoming source inspection
- Quality-wise of this new packaging is more robust

3. Impact of Change and Qualification

3.1 Impact of Change

An important note is that there is no impact on the quality of the actual RTE switch at all with this migration of the packaging.

End user who buys these RTE switch will notice that the packaging colour will be different.

3.2 Qualification

The packaging has been fully qualified to ensure a high consistent quality and performance level.
